- Administration of third-party SaaS (Azure AD, Office 365, Atlassian JIRA, DocuSign, Slack, etc.)
- Approval of IT service requests and assignment of IT tickets among IT infra team
- Monthly reporting of IT infra project status, IT expense report, and cost optimization monitoring
- Endpoint and server vulnerability management and system upgrades before end of life
- Response to system and security alerts related to IT systems in scope, and management of incident response rehearsals to maintain the team's readiness and to meet compliance requirement.
- Periodic review and update of IT policies, SOPs, and documentation
- Support the business team in responding to client's IT infrastructure and IT security questions
- Head the end-user IT support, manage purchase of IT assets, maintain IT inventory and renewal of software and support subscription
- Liaise with external auditor and user department reps and for execution of IT system external audit projects. Perform periodic activities to support IT compliance.
- Lead in some IT projects and other duties as assigned related to IT infrastructure and security





Requirements:

- Minimum Bachelor's degree in Information Technology or equivalent field of study. Preferably with Master degree
- Strong knowledge and hands-on experience in AWS Cloud computing and Azure Active Directory administration, candidates with AWS Solution Architect and Azure Administrator certifications are preferred.
- Minimum of 10 years experiences managing IT Infrastructure in a medium to large companies, with solid experience in leading and managing a global IT Infrastructure team and managing SaaS applications server infrastructure.
- Good interpersonal skills, ability to interact with all levels of staff, effective communicator
